

END USER LICENSE AGREEMENT

Last updated: March 2024

IMPORTANT: PLEASE READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT CAREFULLY BEFORE CONTINUING WITH THIS PROGRAM INSTALL. This End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity and referred to as "Licensee") and Panasonic Corporation Industrial Solutions Company Industrial Device Business Division ("Panasonic") for the software product(s) of this transaction which may include associated software components, media, printed materials, and "online" or electronic documentation ("SOFTWARE PRODUCT"). By installing, copying, or otherwise using the SOFTWARE PRODUCT, you agree to be bound by the terms of this EULA. This EULA represents the entire agreement concerning the SOFTWARE PRODUCT between Licensee) and Panasonic, and it supersedes any prior proposal, representation, or understanding between the parties. If Licensee does not agree to the terms of this EULA, do not install or use the SOFTWARE PRODUCT. The SOFTWARE PRODUCT is protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. The SOFTWARE PRODUCT is licensed, not sold.

The SOFTWARE PRODUCT includes not only proprietary computer programs owned by or licensed by Panasonic, but also open source software programs. As for the open source software programs, refer to the detailed terms and conditions thereof shown in the installation package of the SOFTWARE PRODUCT. Should a discrepancy arise between any of the terms of this EULA and any open source software program license statement, the open source software program license statement shall take precedence over this EULA.

Article 1 Grant of License

Panasonic hereby grants to Licensee and each of the individuals authorized by Licensee to use the SOFTWARE PRODUCT on its behalf, and may include Licensee's employees, contractors and agents ("Authorized Users") a limited, revocable, non-exclusive, non-transferable, non-sublicensable, royalty free (upon full payment of fees) right to access and to use the SOFTWARE PRODUCT only during the term commercially agreed upon in writing between Licensee and Panasonic's affiliate Panasonic Industrial Devices Sales Company of America, Division of Panasonic Corporation of North America (PIDSA) (the "Subscription Period") solely through its Authorized Users, and solely for Licensee's internal business purposes within Licensee's internal computer network at Licensee's designated location(s), provided that Licensee at all times complies with the restrictions set forth in this Agreement, any documentation provided with the SOFTWARE PRODUCT and any usage limitations agreed upon in writing between Licensee and PIDSA. When the Subscription Period is ended, the license to use the SOFTWARE PRODUCT terminates.

Article 2 Restrictions

The Licensee may NOT:

- (1) Provide any other person, including any subcontractor, independent contractor, affiliate, or service provider of Licensee, with access to or use of the SOFTWARE PRODUCT or the documentation, except for Authorized Users;
- (2) Modify, adapt, copy, reverse engineer, decompile, disassemble the SOFTWARE PRODUCT or

otherwise attempt to derive or gain access to the source code of the SOFTWARE PRODUCT or the applicable documentation, except where the terms and conditions of open source software program license statement (including, but not limited to, GPL and LGPL) apply. Should a defect of the SOFTWARE PRODUCT arise owing to your modification, reverse engineering, decompiling, or disassembling, to the extent permitted under the law, Panasonic shall not assume any responsibility for such defect;

- (3) Create derivative works or improvements of the SOFTWARE PRODUCT or the documentation;
- (4) Bypass or breach any security device or protection used by the SOFTWARE PRODUCT or access or use the SOFTWARE PRODUCT other than by an Authorized User through the use of his or her own valid access credentials;
- (5) Input, upload, transmit or otherwise provide to or through the SOFTWARE PRODUCT, any information or materials that are unlawful or injurious, or contain, transmit or activate any harmful code;
- (6) Access or use the SOFTWARE PRODUCT in any manner or for any purpose that infringes, misappropriates or otherwise violates any intellectual property right or other right of any third party, including privacy rights, or that violates any applicable law;
- (7) Access or use the SOFTWARE PRODUCT or the documentation for purposes of competitive analysis of the SOFTWARE PRODUCT or any component thereof, or for the development, provision or use of a competing software service or product or any other purpose that is to Panasonic's detriment or commercial disadvantage;
- (8) Modify, remove or cover proprietary notices in or on the SOFTWARE PRODUCT or the documentation;
- (9) Use the SOFTWARE PRODUCT by methods or for purposes other than those specified in the manual of the SOFTWARE PRODUCT provided by Panasonic or as set forth in Article 1 above, including the combination, use or operation of the SOFTWARE PRODUCT with an application, hardware, software, or in an environment, other than as set forth in the manual of the SOFTWARE PRODUCT or provided or authorized in writing by Panasonic, nor
- (10) Distribute, rent, lease or otherwise transfer the SOFTWARE PRODUCT to any third party without the express written consent of Panasonic.

Article 3 Corrective Action

If Licensee becomes aware of any actual or threatened activity prohibited by Article 2, Licensee shall, and shall cause its Authorized Users to, immediately: (a) take all reasonable and lawful measures within their respective control that are necessary to stop the activity or threatened activity and to mitigate its effects (including, where applicable, by discontinuing and preventing any unauthorized access to the SOFTWARE PRODUCT, and permanently erasing from their systems and destroying any data to which any of them have gained unauthorized access); and (b) notify Panasonic of any such actual or threatened activity.

Article 4 Licensee Content

- 4-1. Licensee shall at all times be the owner of all information, data, video and other content, in any form or medium that is collected, downloaded, uploaded or otherwise received, directly or indirectly from Licensee or an Authorized User by or through the SOFTWARE PRODUCT, including all metadata associated therewith ("Licensee Content") transmitted and stored by the SOFTWARE PRODUCT. Licensee will have sole responsibility for all Licensee Content and will comply with all laws applicable to the Licensee Content; and (b) Licensee retains adequate back-ups of Licensee Content. Licensee acknowledges that Panasonic shall have no liability to inform or advise Licensee as to its legal and compliance obligations with respect to the Licensee Content and Licensee shall solely determine the data retention periods for its Licensee Content. Panasonic will not be liable for any deletion or destruction of the Licensee Content.
- 4-2. Licensee hereby grants Panasonic a limited, non-exclusive, perpetual, royalty-free, right to access and use the Licensee Content as necessary to: (a) provide the SOFTWARE PRODUCT to licensee during the License Term; (b) maintain or improve the SOFTWARE PRODUCT; and (c) for the development of new products and services.
- 4-3. Licensee represents and warrants that: (a) it has provided or will provide all legally-required notices, has obtained or will obtain all legally-required consents and is otherwise compliant with all laws to ensure that Licensee and Panasonic may collect, use, disclose, and otherwise process Licensee Content in accordance with this EULA without violating any laws; (b) the Licensee Content will not infringe, misappropriate or otherwise violate any third party's intellectual property rights, or any privacy or other rights of any third party; (c) it has not and will not transmit or store any Personal Information, including without limitation Social Security numbers, other personal tax ID numbers, military identification numbers, student identification numbers, passport numbers, driver's license numbers, other government identification numbers, financial account data, payment card numbers, biometric information, health or medical information, insurance information, educational information, usernames, e-mail addresses, Internet protocol addresses, passwords, access codes, and security questions, as well as any information that if compromised could permit a person to assume the identity of the data subject ("Excluded Data") within the SOFTWARE PRODUCT, including without limitation, in any free-form fields; and (d) to the best of its knowledge, Licensee Content does not and will not include Excluded Data. Licensee shall inform Panasonic of any Excluded Data within Licensee Content promptly after discovery. For purposes hereof, "Personal Information" shall mean, data that includes information relating to a person that individually or in combination identifies the person by name or by or from which a specific person may be identified, contacted or located, including but not limited to any of the following personally identifiable information ("PII"): government-issued identification numbers (e.g., Social Security, driver's license, passport); financial account information, including account number, credit or debit card numbers; or protected health information ("PHI") relating to a person.
- 4-4. Panasonic may: (a) share or disclose Licensee Content to its service providers; (b) share or disclose Licensee Content to non-parties; and (c) store Licensee Content in the United States and other countries.
- 4-5. Licensee has and will retain sole responsibility for Licensee's use of all Licensee Content. Licensee shall employ all physical, administrative and technical controls, screening and security procedures and other safeguards necessary to control the content and use of Licensee Content, including the uploading or other provision of Licensee Content through the SOFTWARE PRODUCT.
- 4-6. Licensee shall indemnify, defend and hold harmless Panasonic and its subcontractors and affiliates, and each of its and their respective officers, directors, employees, agents, successors and assigns (each, a "Panasonic Indemnitee") from and against any and all losses, damages, liabilities, deficiencies, claims, actions, judgments, settlements, interest, awards, penalties, fines, costs or expenses of whatever kind, including reasonable attorneys' fees and the costs of enforcing any right to indemnification hereunder and the cost of pursuing any insurance claims incurred by such Panasonic Indemnitee in connection with any claim, suit, action or proceeding to the extent arising

out of or relating to Licensee Content including, but not limited to, the use, disclosure, or destruction thereof.

Article 5 Warranty

- 5-1. Panasonic warrants that, for a period of thirty (30) days from the date Licensee acquires the license to the SOFTWARE PRODUCT, the SOFTWARE PRODUCT will operate in material conformity with its documentation and the terms of this EULA, under ordinary operating circumstances. In addition, Panasonic warrants that it shall use commercially reasonable efforts to ensure that the SOFTWARE PRODUCT, upon delivery, does not contain any viruses, Trojan horses, worms, spyware, or other such malicious code. If Licensee notifies Panasonic within the applicable warranty period set forth herein that Panasonic has breached either of these limited warranties, upon verification, Panasonic shall, as Licensee's sole and exclusive remedy, correct, repair or replace the SOFTWARE PRODUCT.
- 5-2. The limited warranties in Section 4-1 above, shall not apply if: (i) the SOFTWARE PRODUCT has not been used in accordance with the terms and conditions of this EULA, the documentation or applicable laws, (ii) the SOFTWARE PRODUCT has been used for a purpose or application for which it was not intended, (iii) the defect is a result of alteration, abuse or damage, (iv) the issue has been caused by the failure of Licensee to apply any updates or upgrades released by Panasonic or any other action or instruction recommended by Panasonic, (v) the issue has been caused by the act or omission of, or by any materials supplied by, the Licensee or any third party, or (vi) the issue results from any cause outside of Panasonic's reasonable control.

Article 6 Disclaimer

- 6-1. EXCEPT FOR THE WARRANTIES PROVIDED IN ARTICLE 4 ABOVE, THE SOFTWARE PRODUCT IS PROVIDED "AS IS" AND PANASONIC HEREBY DISCLAIMS ALL OTHER WARRANTIES ON THE SOFTWARE PRODUCT, EITHER EXPRESS OR IMPLIED STATUTORY, OR OTHERWISE (INCLUDING ALL WARRANTIES ARISING FROM COURSE OF DEALING, USAGE, OR TRADE), AND SPECIFICALLY DISCLAIMS ALL IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR PARTICULAR PURPOSE, TITLE AND NON-INFRINGEMENT OF THIRD-PARTY RIGHTS. WITHOUT LIMITING THE FOREGOING, PANASONIC MAKES NO WARRANTY OF ANY KIND THAT THE SOFTWARE PRODUCT WILL MEET LICENSEE'S REQUIREMENTS, OPERATE WITHOUT INTERRUPTION, ACHIEVE ANY INTENDED RESULT, BE COMPATIBLE OR WORK WITH ANY OTHER HARDWARE, SERVICES, TECHNOLOGIES, INFORMATION, OR MATERIALS, EXCEPT IF AND TO THE EXTENT EXPRESSLY SET FORTH IN THE DOCUMENTATION, OR BE SECURE, ACCURATE, COMPLETE, FREE OF HARMFUL CODE OR ERROR FREE.
- 6-2. The SOFTWARE PRODUCT does not replace the need for Licensee to maintain regular data backups or redundant data archives. EXCEPT AS SET FORTH IN THIS EULA, PANASONIC HAS NO OBLIGATION OR LIABILITY FOR ANY LOSS, ALTERATION, DESTRUCTION, DAMAGE, CORRUPTION OR RECOVERY OF ANY LICENSEE CONTENT.
- 6-3. UNDER NO CIRCUMSTANCES SHALL PANASONIC BE LIABLE FOR ANY DAMAGES (INCLUDING DIRECT, INDIRECT, INCIDENTAL, CONSEQUENTIAL OR SPECIAL OR WHATSOEVER) ARISING OUT OF THE USE OF THE SOFTWARE PRODUCT, INABILITY TO USE THE SOFTWARE PRODUCT, DEFECTS IN THE SOFTWARE PRODUCT (e.g., BUGS, SECURITY HOLES, AND MALFUNCTION), OR OTHERWISE IN CONNECTION WITH THE SOFTWARE PRODUCT.

Article 7 Term

- 7-1. This EULA shall come into effect upon Licensee's unsealing the package of the SOFTWARE PRODUCT, downloading, installing or launching the SOFTWARE PRODUCT or the like and continue until the conclusion of the Subscription Period.
- 7-2. Panasonic may terminate this EULA immediately, if Licensee breaches any of the provisions of this EULA.
- 7-3. Licensee shall, at Licensee's own cost, return, delete or destroy the SOFTWARE PRODUCT and any of its copies within four (4) weeks after termination of this EULA. Panasonic has the right, at their option and expense, to perform a site audit to verify this action.

Article 8 Export Control

Licensee acknowledges that the SOFTWARE PRODUCT may include technology and software that are subject to export control laws and regulations of the United States and other countries. It is the Licensee's responsibility to comply with and abide by those laws and regulations, including, without limitation, the U.S. Export Administration Regulations. Under U.S. law, the SOFTWARE PRODUCT may not be exported or re-exported to (i) any country subject to U.S. embargo; or (ii) to any person on the U.S. Treasury Department's Specially Designated Nationals list or on the U.S. Commerce Department's Table of Denial Quotes or Denied Parties List. Licensee represents and warrants it is not located in, under the control of, or a national or resident of any such country or on any such list. Licensee agrees not to provide any written regulatory certifications or notifications on behalf of Panasonic. Furthermore, Licensee shall neither use nor sell the SOFTWARE PRODUCT for military purposes either directly or indirectly.

Article 9 Intellectual Property Rights

Except for open source software programs (including, but not limited to, GPL and LGPL), all intellectual property rights in the SOFTWARE PRODUCT, including the copyright, belong to Panasonic and/or the licensors of Panasonic. Licensee does not acquire any ownership interest in the SOFTWARE PRODUCT under this EULA, or any other rights to the SOFTWARE PRODUCT other than to use the SOFTWARE PRODUCT in accordance with the license granted hereunder. Licensee acknowledges and agrees that the SOFTWARE is licensed and not sold.

Article 10 Third Party Materials

Licensee acknowledges that the SOFTWARE PRODUCT may include or make available content (including, but not limited to, information, documentation, or applications) or software products licensed by third party provider(s) (collectively, "Third-Party Materials") which are obtained under a license(s) from such third-party provider(s). Licensee acknowledges and agrees that such Third-Party Materials are provided "As Is" without any warranty of any kind. Licensee's use of any Third-Party Materials shall be subject to, and Licensee shall comply with, the terms and conditions in the associated documentation or other printed or electronic materials for Third-Party Materials which can be found within the installation package of the SOFTWARE PRODUCT. By Licensee's acceptance of this EULA, Licensee agrees to be bound by the applicable Third-Party Material terms and conditions. Panasonic is not responsible for Third-Party Materials, including their accuracy, completeness, timeliness, validity, copyright compliance, legality, decency, quality or any other aspect thereof. Panasonic does not assume and will not have any liability or responsibility to Licensee or any other person or entity for any Third-Party Materials.

Article 11 Support Services

Panasonic, PIDSA or its designated representative will provide updates, upgrades and incident management resolution (“Support Services”) for the SOFTWARE PRODUCT during the Subscription Term. Support Services will be provided in accordance with Panasonic’s current Support Services standards, as updated from time to time, as long as the later modification does not materially diminish the Support Services. The current Support Services standards are available at: <https://logiscend.panasonic.com/support-services>, which are incorporated into this Agreement by this reference. Licensee shall only be entitled to Support Services if Licensee is up to date on the payment of all applicable fees.

Article 12 Infringement Indemnification

- 12-1. Panasonic shall, defend, indemnify and hold Licensee harmless against any claim resulting from the direct infringement of any third-party’s intellectual property right of which Panasonic had knowledge, where such claim is predicated on Licensee’s use of the SOFTWARE PRODUCT. Panasonic shall assume the defense of any suit, action, proceeding or objection based on any such claim of infringement brought against Licensee specifically relating to the SOFTWARE PRODUCT by counsel retained at Panasonic’s own expense, and shall pay any damages assessed against or otherwise payable by Licensee in any such suit as a result of the final disposition of any such claim, suit, action, proceeding or objection, provided Licensee, upon receiving notice thereof, promptly notifies Panasonic of such claim or of the commencement of any such suit, action, proceeding and/or objection, or threats thereof, and Panasonic is afforded the opportunity, in its sole and absolute discretion, to determine the manner in which such claim, suit, action, proceeding or objection shall be handled or otherwise disposed of. Licensee shall give Panasonic the cooperation Panasonic requires, at Panasonic’s sole cost and expense, for all reasonable direct costs and expenses incurred by Licensee in rendering such cooperation, except for salaries of the employees of Licensee and fees and expenses of any third party retained by Licensee in the defense of any such claim, suit, action, proceeding or objection. Notwithstanding the foregoing, Licensee may be represented in any such suit by its own counsel at its own cost and expense; provided, however, that Licensee shall not consent to any judgment or decree in any such suit or pay or agree to pay any sum of money or agree to do any other act in compromise of any such claim of a third party without first obtaining Panasonic’s consent thereto in writing, which consent Panasonic may withhold in its sole discretion.
- 12-2. In the event that the use of the SOFTWARE PRODUCT or any part thereof, is preliminarily or permanently enjoined by reason of a finding of infringement or the likelihood of infringement of the patents described in Section 12.1 hereof (collectively, the “Enjoined Software”), Panasonic may, with Licensee’s cooperation, take any one of the following actions, in Panasonic’s sole and absolute discretion: (i) procure for Licensee the right to continue the use of the Enjoined Software; (ii) modify the Enjoined Software so it becomes non-infringing; or (iii) authorize Licensee to return said Enjoined Software and agree to refund the fees paid by Licensee for the Enjoined Software. Upon Panasonic’s fulfillment of either (i), (ii), or (iii) above, Panasonic shall thereafter be relieved of any further obligation or liability to Licensee as a result of any such infringement.
- 12-3. Panasonic shall not be liable pursuant to this Article 12 for any claims, costs, expenses, losses, damages, and attorney’s fees associated with, arising from or related to (i) any designs, specifications or modifications originating with, required by and/or performed by Licensee, (ii) the

combination, operation or use of the SOFTWARE PRODUCT with items not supplied by Panasonic, if the infringement would have been avoided but for such combination, operation or use (iii) applications, content, data, devices, equipment, media, products and/or software provided by Licensee or Licensee's agents, subcontractors, and/or customers for use with, on or in combination with the SOFTWARE PRODUCT, (iv) parts, components, sub-assemblies, software and/or industrial or intellectual property incorporated in or made a part of the SOFTWARE PRODUCT pursuant to Licensee's direction or request, or (iv) Licensee's use of the SOFTWARE PRODUCT contrary to its intended purposes. Licensee shall indemnify and hold Panasonic harmless and defend Panasonic against all claims that the same infringe any patent of third parties upon the terms and conditions equivalent to those applicable to Panasonic's indemnity in Section 12.1 hereof.

12-4 THIS SECTION 12 SETS FORTH THE ENTIRE OBLIGATION AND LIABILITY OF PANASONIC AND ITS AFFILIATES FOR INFRINGEMENT OF ANY PATENTS RELATED TO THE SOFTWARE PRODUCT OR OTHERWISE RELATED TO THIS EULA.

Article 13 Privacy

Panasonic or the SOFTWARE PRODUCT may collect information about or from Licensee's use of the SOFTWARE PRODUCT, including information Licensee provides directly or through automated means, usage, time stamp, device and operating system identification, login credentials, device locale, or other information. Such information is collected and processed by Panasonic to: (i) facilitate the delivery of the SOFTWARE PRODUCT, including verifying compliance with the terms of this EULA, invoicing, and providing support services, and/or (ii) improving Panasonic products and services and user experience. To the extent any of such data includes Personal Information, Panasonic will process such Personal Information in accordance with applicable data privacy laws.

Article 14 Limitation on Liability

- 14-1. IN NO EVENT SHALL PANASONIC BE LIABLE TO LICENSEE OR ANY THIRD PARTY FOR ANY (I) LOSS OF USE, BUSINESS, GOODWILL, REPUTATION, REVENUE OR PROFIT (II) LOSS, DISCLOSURE OR CORRUPTION OF DATA, (III) BUSINESS INTERRUPTION OR INCREASED COSTS OR (IV) FOR ANY CONSEQUENTIAL, INDIRECT, INCIDENTAL, SPECIAL, EXEMPLARY, OR PUNITIVE DAMAGES, WHETHER ARISING OUT OF BREACH OF CONTRACT, TORT (INCLUDING NEGLIGENCE), OR OTHERWISE, REGARDLESS OF WHETHER SUCH DAMAGES WERE FORESEEABLE AND WHETHER OR NOT PANASONIC HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES, AND NOTWITHSTANDING THE FAILURE OF ANY AGREED OR OTHER REMEDY OF ITS ESSENTIAL PURPOSE.
- 14-2. AGGREGATE LIABILITIES OF PANASONIC IN CONNECTION WITH THIS EULA OR THE SOFTWARE PRODUCT SHALL IN NO EVENT EXCEED THE FEES PAID BY LICENSOR TO PANASONIC FOR THE SOFTWARE PRODUCT.

Article 15 Governing Law and Jurisdiction

- 15-1. This EULA shall be governed by the laws of the State of New York without giving effect to any choice or conflict of law provision or rule. The 1980 United Nations Convention on Contracts for the International Sales of Hardware, as amended, shall not apply to this Agreement.

15-2. Any legal suit, action, or proceeding arising out of or related to this Agreement or the Support Services, or other subject matter hereof, or any transactions contemplated hereby, shall be instituted exclusively in the federal courts of the United States or the courts of the State of New York in each case located in New York City, and each party irrevocably submits to the exclusive jurisdiction of such courts in any such suit, action, or proceeding. Service of process, summons, notice, or other document by mail to such party's address set forth herein will be effective service of process for any suit, action, or other proceeding brought in any such court.

Article 16 Modification

Panasonic reserves the right, in its sole discretion, to make any changes to the SOFTWARE PRODUCT that it deems necessary or useful to maintain or enhance the quality or delivery to its customers, the competitive strength of or market for the SOFTWARE PRODUCT, the cost efficiency or performance of the SOFTWARE PRODUCT, or to comply with applicable law. In addition, Panasonic may, in its sole discretion, amend or modify the terms and conditions of this EULA and/or any policies referenced herein at any time by notice to Licensee, including without limitation by posting the revised terms and conditions on its website at: <https://logiscend.panasonic.com/terms-and-conditions>. Such amended or modified terms and conditions become effective on posting. Licensee's continued use of the SOFTWARE PRODUCT after the effective date of the amendments and/or modifications will be deemed acceptance of the amended or modified terms.

Article 17 U.S. Government End User Rights

To the extent Licensee is a U.S. federal, state, or local governmental authority (or a foreign governmental authority) or a Licensee buying for or on behalf of a governmental authority or any other entity or instrumentality of a governmental authority including entities that receive public funding, in whole or on part (collectively, "Governmental End User"), Governmental End User agrees that all software, software documentation and/or technical data included in or provided together with the SOFTWARE PRODUCT are commercial items, as defined in 48 C.F.R. § 2.101 and any similar provisions in the applicable jurisdiction; and constitute commercial computer software and commercial computer software documentation, as defined in 48 C.F.R. § 252.227-7014(a)(1) and as used in 48 C.F.R. §§ 12.212 and 227.7202 (or similar provisions in the applicable jurisdiction); or constitute commercial "technical data," as defined in 48 C.F.R. § 252.227-7013(a)(15) and as used in 48 C.F.R. §§ 12.211, 227.7102-1, 227.7102-2, and 252.227-7015 (or similar provisions in the applicable jurisdiction). Governmental End User further acknowledges and agrees that all software, software documentation, and/or technical data included in or provided together with the SOFTWARE PRODUCT was developed entirely at private expense and that no part of the SOFTWARE PRODUCT was first produced in the performance of a contract with any Governmental End User.
